

# **ANNOUNCEMENT FOR AUCTION**

HEXUM Földgáz Company Limited by Shares (registered office: 2151 Fót, Fehérkő utca 7. building, company registration number: Cg. 13-10-042153, tax number: 13780960-2-44, hereinafter referred to as HEXUM Földgáz Zrt. or the Tendering Party) announces an Auction for the booking of free storage capacities on the day hereunder. The Offered Price is understood as a net amount, excluding VAT and any other official charges or tax-like amounts. The Offered Price does not include the injections turnover fee and the withdrawal turnover fee, which the Tenderer will pay in accordance with the decision of the Hungarian Energy and Public Utilities Regulatory Office setting the natural gas storage fee for the given storage year, based on its monthly turnover. The Offered Price does not include any fees for specific services eventually used by the Tenderer.

Total Capacity Booking Fee payable by the successful Tenderer for the Contract Period: the Offered Price (EUR/MWh) multiplied by the Mobile Capacity (MWh) booked by the Tenderer under this Auction.

HEXUM Földgáz Zrt. will involve ENERGIQ Kft. and its subcontractor Fluenta Europe Kft. as Auction Facilitator.

# Registration

The System User shall register as an Auction participant in order to participate in any Auction announced by the Tendering Party.



The System User will be eligible to participate in a particular Auction announced by the Tendering Party as a System User Eligible for submitting an Offer if:

- it has electronically submitted the registration documents required for the Auction to the Tendering Party through the Auction Registration Surface operated by the Tendering Party and these documents have been accepted;
- the amount of the Tender Security relating to the Auction has been credited to the Tendering Party's bank account by the deadline

#### Access to the Auction Registration Surface:

The System User can indicate his intention to get access to the Auction Registration Surface by filling in the online form available on the Tendering Party's website (gaztarolo.hu). By completing the form required to obtain access to the Auction Registration Surface and by submitting his data, the System User will accept the provisions of the User IT Rules (Appendix no. 2). After filling in the form and submitting the data, the Tendering Party will check the data submitted and, if they are correct, will send the technical information required to get access to the Auction Registration Surface to the System User by e-mail within 2 working days, who will therefore become a System User having a Technical Registration.

#### Documents required for registration:

A System User having a Technical Registration has the possibility to submit the registration documents for a given Auction electronically to the Tendering Party via the Auction Registration Surface. The following documents shall be submitted:

HEXUM Földgáz Zrt. reserves the right to request the participant to rectify any deficiencies in form or content or other non-conformities during the individual examination of the documents submitted during the Registration, by setting a deadline.

In the event of failure to comply with the request for the completion of the registration by the deadline, or failure to comply with the request, HEXUM Földgáz Zrt. will reject the registration with final effect and the participant will not be allowed to participate in the Auction.

If the documents are received after the deadline set for Registration, the Registration will be deemed unsuccessful and invalid.

In the case of a valid Registration, HEXUM Földgáz Zrt. will confirm the successful Registration to the Tendering Party via e-mail.

During the Auction, HEXUM Földgáz Zrt. undertakes to handle the documents and data submitted to the Auction confidentially and will not disclose them to third parties.

#### Tender Security

The Tender Security will be a financial security specified by the Tendering Party in the amount of 50.000,- EUR, i.e. fifty thousand Euro for this Auction. The Tenderers shall pay the amount of the Tender Security during the Registration Procedure by bank transfer to the bank account of **HEXUM Földgáz Zrt. IBAN: HU08 1176-3945-0210-5888-0000-0000, in all cases referring to the exact auction ID (''2/2024 Storage Capacity Auction - 1 year'')** in the communication field, and a statement and bank receipt confirming the transfer shall be attached to the documents that will be submitted during the Registration Process. The amount of the Tender Security shall be credited to the Tendering Party's bank account by the registration deadline specified in the Auction Announcement.

#### Draft contracts:

The Tendering Party will within 2 working days after the successful Registration send to the Tendering Parties Registered for the given Auction a sample of the Gas Storage Contract and,



if relevant for the given Auction, the model of the Secondary Capacity Trading Contract for interruptible capacities.

## Submission of an offer

Electronic Auctions will be conducted through the Electronic Auction Surface provided by the Auction Operator, and the Tendering Parties may submit their Offers through this surface in accordance with the rules of the relevant Electronic Auction Procedure.

#### Access to the Electronic Auction Surface:

Only Tendering Parties that have successfully registered for a given Auction will receive access to the Electronic Auction Surface for the given Auction. The data required for access will be sent by the Auction Operator to the e-mail address of the registered Tendering Parties specified during the registration process.

The Auction Operator will provide the Tendering Parties with the opportunity to test the Electronic Auction Surface and get prepared for the Auction within the timeframe specified in the Auction Announcement. The Auction Operator will provide telephone and electronic support to the Tendering Parties during the Auction.

By logging into the Electronic Auction Surface, the Tendering Parties who have registered for the relevant Auction agree to follow the rules of the Electronic Auction Process.

#### Procedure for submitting offers:

Offers in a given Auction may be submitted through the Electronic Auction Surface provided by the Auction Operator in accordance with the relevant Electronic Bidding Rules.

# For the purposes of this Auction, the rules set out in the Dutch Electronic Auction Rules will apply.

Before the starting date of the Electronic Auction Process, the Tendering Party shall specify the Bid Quantity, i.e. the quantity of capacity (number of announced capacity bundles), which the Tendering Party will bid to book at the Auction Price it has offered within the Electronic Auction Process. If the Tendering Party fails to specify the quantity or is late in doing so, and nevertheless participates in the Electronic Auction, the Tendering Party will automatically, without any further notice, consider the Bid Quantity for the Tendering Party as 1 Capacity Bundle (1 LOT) and will count it accordingly in the evaluation of the bidding process.



A Tendering Party may submit offers in the Auction for up to the number of storage bundles specified in the section "Maximum number of bid bundles" that can be applied for.

The Tendering Party will determine the Initial Price of the capacity bundles to be sold in the Auction. The Initial Price will be published at the start of the Electronic Auction on the Electronic Auction Surface to the Tendering Parties participating in the Auction.

Bids can be submitted with a valid bid made in the Electronic Auction Process. The Offer Price submitted in the Electronic Auction Process applies to one capacity bundle (1 LOT). The Tendering Party will consider as valid offers within the Electronic Auction Process all bids submitted through the Electronic Auction Surface using the e-mail address provided by the Tendering Party during registration.

The Offer submitted by the Tendering Party in the Auction is considered as a proposal for concluding a contract, and the Tendering Party will remain bound to the Offer until the 15th (fifteenth) working day following the date of announcement of the auction results of the auction named as "2/2024 Storage Capacity Auction - 1 year", i.e. until March 20, 2024.

The Offer Price is understood as a net amount, exclusive of VAT and any other official charges or tax-like amounts.

### **Miscellaneous provisions**

HEXUM Földgáz Zrt. will notify the winning Tendering Party(ies) following the evaluation in accordance with the provisions of the Auction Rules.

Following the Auction, the Tendering Party and the winning Tendering Party(ies) will conclude a Natural Gas Storage Contract for the awarded storage capacities in accordance with the provisions of the Auction Rules.

We would call the attention of the Tendering Parties to the fact that contrary to the Auction Rules, HEXUM Földgáz Zrt. does not accept any parent company guarantee as a contractual security for the present capacity auction named as "2/2024 Storage Capacity Auction - 1 year", considering the current geopolitical situation and, in this context, the uncertainties related to the availability of natural gas resources and the unpredictable impact of anticipated further sanctions, furthermore, for the aforementioned reasons, the



# individual gas storage draft contract attached to the Auction Announcement differs from the Auction Rules.

The Tendering Party explicitly reserves the right to suspend the Auction announced under this Auction Announcement for the entire duration of the Auction without giving any reason, or to withdraw the Auction Announcement without giving any reason.

In the event the Auction is withdrawn, the Tendering Party will not have no liability towards the registered Tendering Parties for any damages, interest, costs or other liabilities, and the Tendering Parties will bear their own damages and costs.

The Tendering Party reserves the right that in the event laws introduce restricting measures to movement or the Tendering Party imposes other restrictions with reference to war emergency, it can determine acts that do not require personal presence instead of those acts that require personal presence in the Auction Rules and/or the Auction Announcement, or that it can, if necessary, modify the deadlines specified in the Auction Rules and/or the Auction Announcement to a reasonable and justified extent. If any such measure is introduced, the Tendering Party will inform all participants of the process by e-mail.
